## OPEN DATA CHARTER MEMBERSHIP

The Municipality of the City of Mendoza committed to adopting the International Open Data Charter.

The International Open Data Charter will be implemented through the processes and activities of transparency, citizen participation and governance, in which the Municipality has already been advancing over recent years and which, currently, are in full swing, development, mainly through the Open Data Portal of the City of Mendoza.

# OPEN GOVERNMENT PARTNERSHIP OGP LOCAL MEMBERSHIP

The City of Mendoza was selected by the OGP as an integral member. The Municipality applied for membership accompanied by five civil society organizations (CSOs): the Latin American Center for Human Rights, the Nuestra Mendoza Foundation, the National University of Cuyo, the University of Mendoza and the Maza University. The cluster applied appealing to a superior value proposition to promote government openness at the local level and the Alliance endorsed the Capital's application in recognition of its high-level political commitment. The OGP Local program aims to harness the innovation and momentum demonstrated by local governments and civil society partners around the world. OGP is a platform for these governments and civil society to come together to make their governments more open, inclusive and responsive, modeling the values and principles of the Declaration and Open Government processes.
